Treasurer's report was presented by Susan Gregg. There were some invoices yet to be paid for the show and Dee and Susan will reconcile them by the next meeting and report back. Arlene moved the report be approved as presented with a report next month on the reconciliation solution. Stephanie seconded and the motion was approved.

PERMANENT COMMITTEE REPORTS:



Show Management

Show Committee meeting called to order at 6:10 pm by President Tammy Fagan.

Present: Tammy Fagan, Arlene Rhodes, Pat White, Megan Bretey, Susan Gregg, Stephanie Soule and Dee Closson.

Arlene offered to take minutes in Deb's absence.

Arlene read show meeting minutes from prior meeting. Stephanie moved to approve, Susan seconded; motion approved.

Sanction Show Report: Manager Pat White said the TD report was very favorable. A big thanks went out to the show manager and secretary and Susan Gregg for getting a new TD at the last minute and rescheduling all rides on Saturday. Pat White said no problems; food vendor was only charged half her rate due to such low attendance. Vendor mentioned most shows don't charge her a vendor fee. There was one late report of VS related concern, but it was unfounded and no action taken. Susan Gregg reported on show expenses vs. revenue. About \$1900 was the net cost for this show.

October Show: Dee Closson said there are about 26 rides each day. Arlene Rhodes reported we need a food volunteer otherwise the show day volunteers are all lined up. Pat said the judge would stay with someone if we found a place. Stephanie Soule will contact the judge and see if she would stay with her. Dee mentioned that we currently group all our 21 and under riders together. Arlene moved that next year we divide up our youth classes in to two groups: Juniors - 14 and under; and Young Riders, 15 to 21. Pat seconded and everyone approved.

2015 Show Schedule:

Tammy Fagan submitted our dates to the fairgrounds office and she will call tomorrow and see if we did get our dates approved. She did not get an email from them and some other clubs did. The cost for the new arena will be more but it is not clear how much more it will be. There will be yearly bidding for event dates. It is possible for two clubs to share both arenas, but there are some concerns such as insurance coverages, shared barn area, shared RV areas and how to manage that. Arlene moved and Dee seconded to ask the fair grounds for the club to use the newer arena if it was available due to the better footing. Dee seconded and it was approved. Susan Gregg reported that two of the judges for next year have been selected, and other emails are out with requests to judges.

New business: We will need a show committee chair next year as this is Tammy Fagan's last year chairing this committee. A volunteer is needed for this.

Next Show Committee Meeting: October 21st at 6:00 pm. The location to be announced. If others have ideas on where to meet we are to let Tammy know.
